"Your Worship, on December 30th, 2005, in accordance with the requirements of The Municipal Act, written notice of this meeting was delivered to all members of City Council (including those absent from the Chamber) advising that a Special Meeting of City Council would be convened on this date with respect to an agreement between the City of Brandon and the Rural Municipalities of Cornwallis and Elton and the Brandon and Area Planning District on annexation and Planning District services, and the matter of tax shifting changes to the City's 2006 Financial Plan. As all statutory requirements have been met and there is a quorum of City Council present, it is lawful to proceed with the meeting."

GENERAL BUSINESS

(A) AGREEMENT - CITY OF BRANDON, RURAL MUNICIPALITIES OF CORNWALLIS, ELTON AND BRANDON AND AREA PLANNING DISTRICT BOARD

City Council considered a report from the General Manager of Development Services dated December 30th, 2005 which provided an overview of the process, the issues and interests, the agreement in principle, implementation steps and conclusions resulting from negotiations with the Rural Municipalities of Cornwallis and Elton with respect to the Brandon and Area Planning District Board, service delivery and annexation.

- (i) the City of Brandon's annexation of land from the Rural Municipalities of Cornwallis and Elton;
- (ii) a proposed service delivery model that will give the City and the Rural Municipalities greater autonomy over local planning matters and streamline service delivery; and
- (iii) maintaining the Brandon and Area Planning District Board. CARRIED.
- (B) TAX SHIFTING CHANGES PROPOSED FOR FINANCIAL PLAN

Submitted for consideration was a report from the General Manager of Corporate Services dated January 5th, 2006 with respect to tax shifting changes for the Financial Plan.

Mr. McMillan appeared before Council to provide information on the legislative options available to Council to moderate shifts in tax burdens due to reassessment.
