

**CONTINUING CONSOLIDATION**  
**BY-LAW NO. 6344/71/95**

**AS AMENDED BY BY-LAW NO. 7030.**

**BEING A BY-LAW of The City of Brandon to permit expanded retail shopping on certain public holidays including Sundays as provided for in The Retail Businesses Holiday Closing Act.**

**WHEREAS Sections 2 and 3 of The Retail Businesses Holiday Closing Act do regulate and control persons who own or operate retail business establishments that admit members of the public therein or sell or offer for sale any goods or services therein on a public holiday including Sundays;**

**AND WHEREAS subsection 4.1(2) of said Act provides for a council of a municipality to adopt a by-law to exempt certain retail business establishments from the regulations and controls set out in Sections 2 and 3 of said Act;**

**AND WHEREAS it is deemed expedient and in the best interests of The City of Brandon to grant such exemption.**

**NOW THEREFORE the Council of The City of Brandon in open session assembled, enacts as follows:**

- 1. THAT pursuant to subsection 4.1(2) of The Retail Businesses Holiday Closing Act, the following are hereby exempt from Sections 2 and 3 of said Act:**
  - a) every retail business establishment in The City of Brandon where the number of persons, including the owner, employed for the sale of goods or services does not ordinarily exceed four (4) persons at any one time; and**
  - b) every retail business establishment in The City of Brandon where more than four (4) persons, including the owner, are ordinarily employed for the sale of goods or services at any one time but only if:**
    - i) the holiday is other than New Year's Day, Good Friday, Easter Sunday, Canada Day, Labour Day, or Christmas Day; and**
    - ii) that retail business establishment does not admit members of the public therein or sell or offer for sale any goods or services before 9:00 a.m. or after 6:00 p.m. on the holiday.**

- 2. THAT the provisions of this by-law shall come into full force and effect on the 1st day of January A.D. 1996 and shall remain in full force and effect until this by-law is amended or repealed.**
