

Thank you for booking your event at the City of Brandon - Sportsplex.

We appreciate your cooperation in reading and following these facility user regulations. It is the responsibility of the person signing this contract to inform all participations of the regulations concerning the use of this facility.

While in the Sportsplex, all persons are expected to conduct themselves in a safe, respectful manner.

1. All bookings must be paid prior to facility usage.
2. Alcoholic Beverages and Smoking in the Sportsplex are strictly prohibited.
3. Cost for repairs due to damages caused by users will be charged to that user group.

POOL USERS

With the implementation of our Aquatic Safety Strategy, we thank you for following these regulations to make your aquatic visit as safe as possible. The regulations vary slightly depending on general admission (public swims) and group rentals (private bookings). Please contact us for further information.

1. Proper swim attire must be worn. Cut off jean shorts are not allowed and T-shirts are not recommended. ALL PATRONS MUST WEAR A SWIMSUIT.
2. If Emergency Buzzer is sounded - CLEAR POOL IMMEDIATELY.
3. **POOL ENTRY REQUIREMENT – TO ENTER THE POOL WITHOUT A GUARDIAN, A CHILD MUST BE SEVEN YEARS OF AGE OR OLDER AND AT LEAST 46 INCHES TALL.**
4. For those children requiring a guardian, anyone who is 12 years of age or older may accompany the children to a maximum of 4 children per guardian.
5. All children accompanied by a guardian as well as ALL children in a PFD, must be within one arm's length from that guardian AT ALL TIMES. The guardian must be in the water supervising the child's play and activity at all times.

Private Bookings:

In addition to the regulations above, the following regulations also apply:

1. The waterslide charge includes the additional lifeguard required to supervise the waterslide activity. This is an additional fee and is not included in your initial rental.
2. Lifeguards are not included in your initial rental. The ratio of lifeguards to patrons is as follows: 1 lifeguard – less than 30 patrons; 2 lifeguards – less than 70 patrons; 3 lifeguards – less than 100 patrons; 4 lifeguards – less than 150 patrons; 5 lifeguards – less than 200 patrons. This ratio does not include the additional adult accompaniment necessary for all children that do not meet the height & age requirement.
3. All group rentals will receive a brief orientation at the beginning of their booking when the lifeguards will review the rules, distribute PFD's as necessary and answer any questions.

ARENA USERS

1. No persons are allowed on the ice while maintenance is in progress and/or zamboni gates are open.
2. Users must vacate the ice surface immediately upon the expiration of their rental period.
3. All floods are included in the user group's rental period.
4. It is up to the user groups to ensure that the dressing rooms are left clean and ready for the next group.

RACQUETBALL USERS

1. All racquetball players must wear eye protection at all times.
2. Proper footwear must be worn. Shoes that mark the floors are prohibited.
