One prize will be awarded per contest winner. **ONLY ONE ENTRY PER PERSON IS PERMITTED.** The odds of winning will be determined by the number of eligible entries received by the contest closing date.
3. **Selection Process.** All selections will be made at random from among all eligible entries received by the contest closing date and time. Draws will be made at **12:00 p.m. on Tuesday, March 1, 2022.** Selected entrants will be contacted through their email or phone number provided in the survey.
4. No correspondence will be entered into except with potential winners, except for survey participants who shared their contact information in order to further participate in the process.
