7.0 **New Business**

A. Senior Resource Guide Reprint

The Committee was advised that \$4,600 currently remains in the budget and one of the items the Committee had considered during earlier budget discussions was the reprint of the Senior Resource Guide. Two options were considered:

- a) Reprint approximately 1,000 copies of the 2nd Edition of the Senior Resource Guide with minor revisions.
- b) Postpone the printing of a 3rd edition until 2024 and include a section for advertising to build a revenue stream for printing future editions of the guide. Applying for a grant, such as the AF MB Community Collaboration grant may provide an opportunity to source funds to support the administrative costs associated with the expanded 3rd edition.

That the Committee agree to explore the reprint of the Senior Resource Guide, purchase marketing tools and sponsor Holiday food hampers to a maximum of the remaining current budget. Carried

ACTION ITEM: Susan Boyachek will pursue a quote and subsequent reprint for the Senior Resource Guide, investigate options for pens and jar openers and share details with Committee prior to order, and organize the sponsorship of Holiday food hampers on behalf of the Age Friendly Committee, all to be completed prior to yearend.

B. Grant Opportunities

Doug Fraser advised the Committee that he has received an email from Rachel Heron, BU Geography Department and Director for the Centre for Critical Studies of Rural Mental Health regarding the AF MB Community Collaboration Grant. She has suggested she could lead the writing of the grant submission with input from those who work more directly with older adults or identify as an older adult themselves. She has been working on a project that looks at public space (like parks, paths, and streets) and movement through the city and has heard from older adults that places of rest and shade were important to them. She is enquiring if this grant could be used to enhance what we have to offer with guidance from Age Friendly, Seniors for Seniors, and the Alzheimer Society.

The Committee agreed this is an excellent opportunity and Nancy McPherson and Doug Fraser should follow up on this proposal.

c. Review of Member terms expiring December 2023

The Chair confirmed that three of the six citizen representative committee member terms will be expiring December 31st including Meryl Orth, Areta Donnelly and a position that is currently vacant. The Chairs agreed to review all member terms to confirm this information as quickly as possible. Committee Members were reminded of the deadline to reapply. The City has published the annual notice seeking volunteers to sit on all committees including the Age Friendly Committee.

D. Confirm date of December meeting

Due to the proximity to the holiday season, the Committee agreed to reschedule the next regular meeting to December 14, 2023 beginning at 4:45 pm.
