- 4. Obtain a copy of your notice of assessment from the Canadian Revenue Agency

- 2. Under the Building and Plumbing Permits heading, select **Apply for a Building or Plumbing Permit**.
- 3. Please fill out your permit (see example below) selecting **Environmental Initiatives** as the application type, **Fixture Rebate** as the category of work being done and describe the work as **upgrading your toilet**.
- 4. Proceed with the next steps, providing your specific information.
