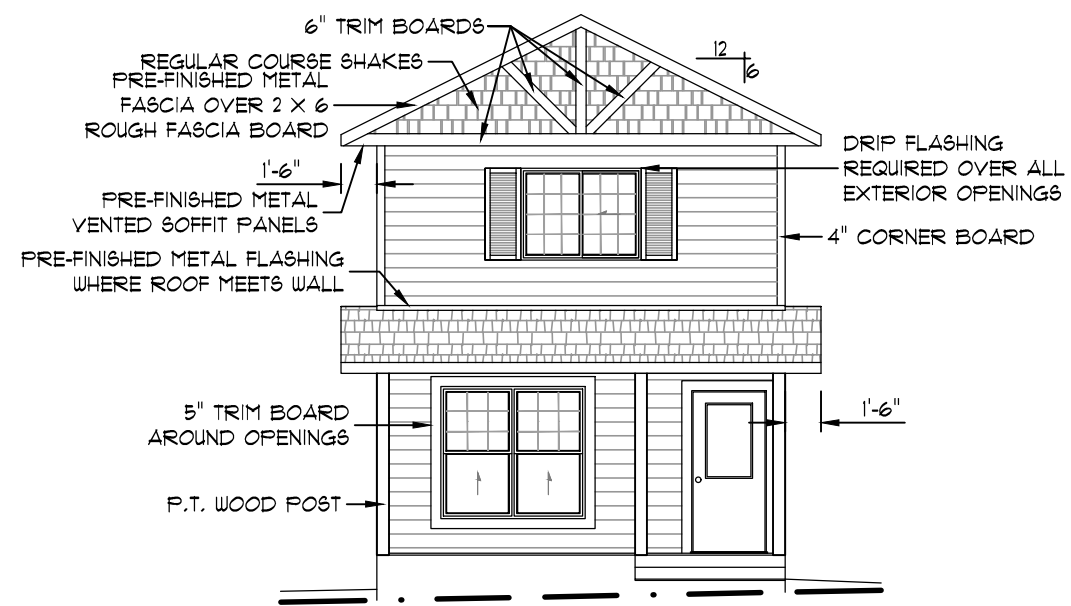

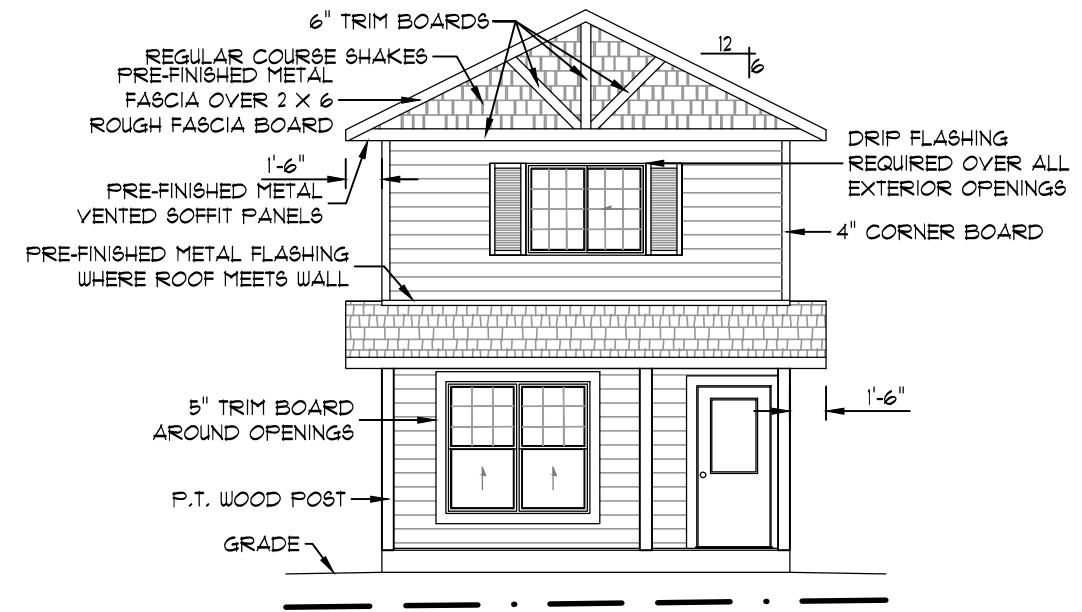

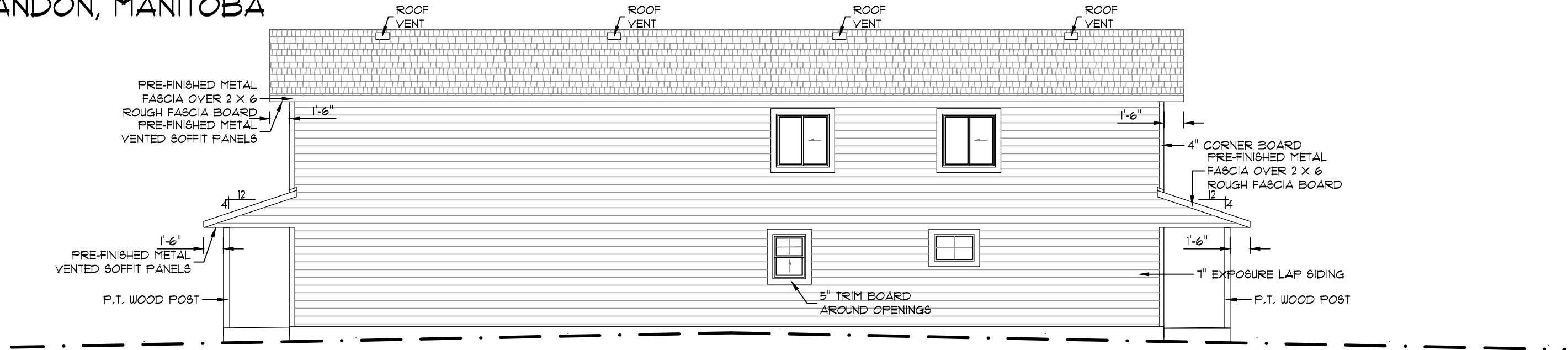


E1 WEST EXTERIOR ELEVATION

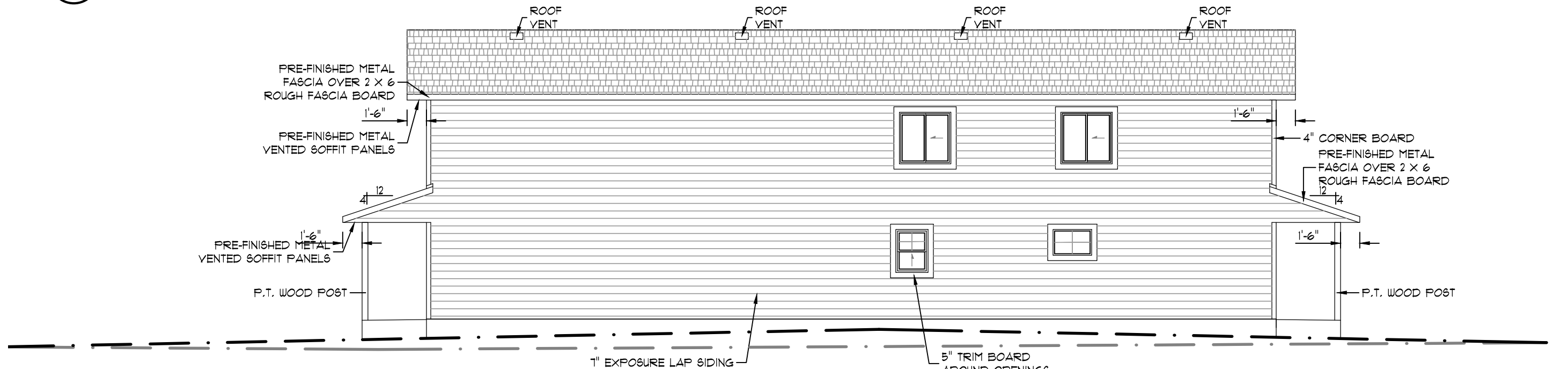


E2 EAST EXTERIOR ELEVATION

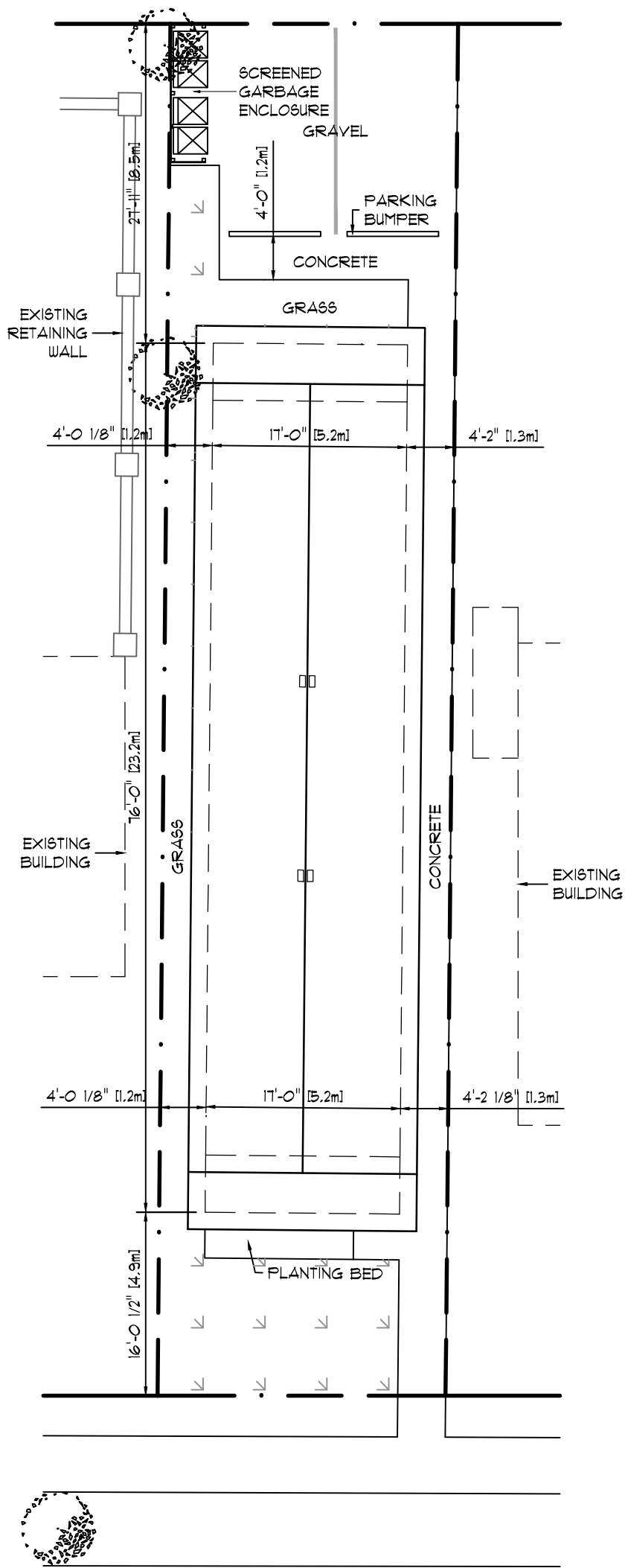


E3 SOUTH EXTERIOR ELEVATION
