Message From the *Chief of Police*

It has been an active, progressive year in 2025 for the Brandon Police Service with new programs, processes and operating procedures that have been impactful and transformed overall service delivery. I am privileged, as the Chief of BPS, to be a part of such progress and to be amongst a culture of excellence and dedicated public safety professionals. I take great pride in the cadre of Brandon Police Officers, who in my opinion are second to none. These officers invest themselves wholeheartedly in community contribution, maximizing the safety and wellbeing within our beautiful community. Brandon Police Service is leading with vision and innovation, advancing impactful initiatives and setting a benchmark for police service delivery in the province. I am ecstatic to highlight some of the accomplishments in 2025 that have fostered community connection, enhanced public safety and ameliorated the delivery of compassionate police service delivery.

BPS Evacuation Response

On May 28, 2025, the Province declared a state of emergency due to wildfires in Northern Manitoba. The City of Brandon rallied to assist our neighbors in crisis extending their compassion to the those displaced by this threat. At the peak of this effort, there were as many as **1175** displaced evacuees residing in Brandon hotels. Brandon Police Officers, Cadets and Provincial First Nations Safety Officers (FNSO's) aligned their efforts, maximizing communication, visibility and presence to support and protect evacuees and Brandon citizens alike. These collective efforts

ensured the maintenance of peace and security amid a traumatic, challenging time within our Province. The hospitality of the City of Brandon throughout this effort was on full display in the gracious reception extended to citizens displaced and in distress.

In-house Paramedics within BPS Detention Facilities

On July 3, 2025, Brandon Police Service realized the addition of trained paramedics into our BPS Detention facility. This has been a transformative program for BPS, enhancing care for the vulnerable and improving police service delivery to the citizens of Brandon. Prior to this, Brandon Police Service officers spent hours waiting with detainees at Brandon Regional Hospital for medical evaluations required prior to detention in police cells. With the new efficient process that permits paramedics to undertake medical evaluations in-house at BPS Detention, police officers are freed up to patrol the City of Brandon, additionally, emergency room physicians are no longer burdened with this responsibility, enabling them to care for the many citizens of Brandon waiting in ER for medical attention.

Since the implementation of the paramedics into BPS Detention, there has been a precipitous increase of over 100% in persons detained due to intoxication and drug impairment. Though this speaks to the challenges of addictions within the City of Brandon, it also reinforces the enhanced support that BPS can provide for those that are in need of shelter and care while compromised and in a state of vulnerability due to the substances consumed. The safety of the

streets of Brandon is enhanced by increased sobriety, whilst the detained are provided with addiction supports and referrals. The realization of this program has undoubtedly contributed to a safer community and has enabled both police and health care providers to enhance their level of care and intervention.

Crisis Response Unit

On October 20, 2025, Brandon Police Service launched another notable, innovative program, the Crisis Response Unit (CRU). Since implementation, BPS officers have been partnered with Prairie Mountain Health psychiatric nurses in response to calls involving mental health crisis. CRU represents a critical step forward in how we respond to mental health crisis, bringing police, health professionals, and community partners together to deliver timely, trauma-informed care with dignity and compassion. This unit is reducing unnecessary hospital transfers, supporting frontline officers, and ensuring people in crisis are connected to the right help, strengthening both community safety and well-being. Since its inception, CRU has been deployed on nearly 200 occasions. Its engagements and interactions have encompassed community visits, telephone contacts, consultations, collateral supports, Mental Health Act form applications, referrals to external services, and community outreach.



It has been a furious pace this year; operationally an unprecedented influx of wildfire evacuees taxed our membership, as did the adoption of new programs and specialized resources, incorporating paramedics and public health professionals to work alongside our police officers in delivering the best possible services to our citizens. All this coupled with the adoption of new digital technologies has forced us to be nimble, flexible and adaptable to an ever-changing environment. The pace of change faced by our uniformed men and women and civilian staff has been challenging but the staff of BPS have risen to every challenge with dedication and compassion, collectively protecting the citizens of Brandon in the process. BPS employees have demonstrated their compassion, persistence and excellence this year and I count it a blessing and a privilege to work alongside them in the maintenance of peace and security within the City of Brandon.

In 2025 we hired a total of **20 employees**, **11** of the new hires were police recruits. Police Service Dog Unit (PSDU)



PSD STORM began his service with the Brandon Police Service on December 13, 2017, alongside his handler, Cst. Haggarty. Together, they formed a strong and trusted partnership, serving the community with dedication and professionalism throughout their years together.

Over more than seven years in the Police Service Dog Unit, Storm demonstrated loyalty, skill, and an unwavering commitment to duty. He contributed to numerous investigations through his work in apprehensions and interdictions, and supported many Tactical Response Team deployments, helping to enhance public safety in Brandon.

Beyond his operational role, Storm was a valued partner and companion, leaving a lasting impression on those who worked alongside him.

On July 11, 2025, PSD Storm passed away peacefully in his sleep. His service and dedication will be remembered with deep gratitude and respect by his colleagues and the community he served.



PSD MERIT

On October 1st, 2025, Cst. Nagorski began his training with PSD Merit.

Merit was born in 2025 and is expected to be on full active duty in June of 2026.



Digital Evidence Management System (*DEMS*)

In June of 2025, Brandon Police Service fully completed the implementation of a **Digital Evidence Management System (*DEMS*)** through Axon. This began as a pilot project in collaboration with the Province of Manitoba and Manitoba Prosecution Services (*MPS*) in 2024.

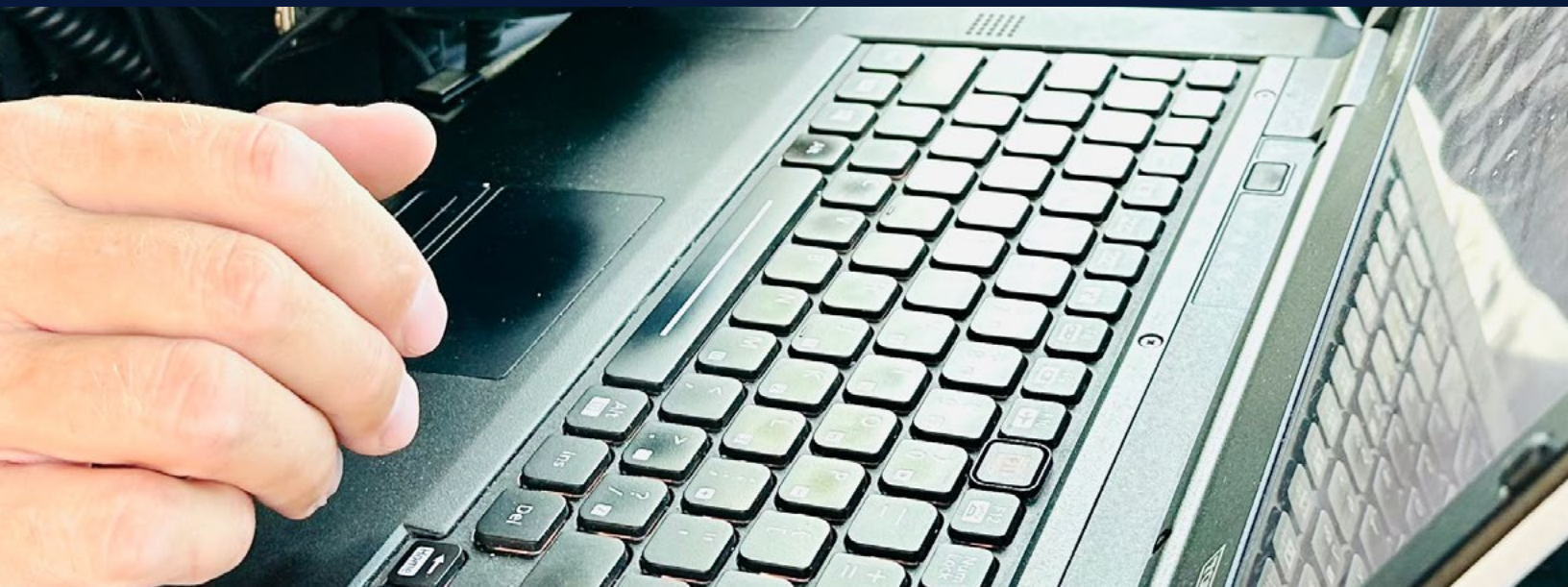
This enables the Police Service to electronically share digital evidence such as surveillance camera footage, statements, social media content, photographs, audio and video with *MPS*.

This system allows businesses and members of the community to share digital evidence electronically with the police service by way of a community request.

In December all police cruisers had Axon dash cameras, rear seat compartment cameras and Automatic License Plate Readers (*ALPR*) installed by Axon. Some were new installations and others were replacing a dated fleet of camera and *ALPR* equipment.

Beginning in April of 2026, Brandon Police Service will begin to implement Body Worn Cameras (*BWCs*) for all front-line officers. This implementation is expected to take several months with full implementation happening by the end of August.

As a result, a new **Digital Evidence Management Section** will be formed in 2026 to help with the processing of an abundance of digital evidence.



Downtown Strategy



The Brandon Police Service (BPS) continues to manage a high volume of calls for service within the downtown corridor, which consistently represents approximately **30% of the City of Brandon's total call workload**. The 2025 downtown strategy, conducted from May 23 to September 4, emphasized community engagement, strategic police visibility, a balanced approach to proactive and reactive policing, and a data-driven framework to monitor trends, activity, and operational effectiveness.

During this period, BPS platoons logged **2,601 patrol and response hours within the downtown corridor**, equating to approximately 108 officer-days of activity. Police cruisers traveled 19,334.41 kilometres, with 8,663 instances recorded where a cruiser remained in the corridor for three minutes or longer.

Cadets played a significant role in supporting operations, contributing 493.70 hours in vehicle patrols, 347.20 hours on foot patrols, 62.28 hours in community engagement, and 320.78 hours assisting officers in various capacities.

While approximately 30% of overall calls continued to originate from the downtown corridor, total calls **decreased by 1.5% compared to 2024**. Overall crime also declined during the strategy period, with increases limited to traffic enforcement and support for partner agencies. Several key categories experienced notable reductions, including a 12% decrease in social disorder incidents, a 4% decline in court order-related calls, and a nearly 24% reduction in property-related offences. Crimes against persons also saw a slight decrease, reflecting the positive impact of the 2025 strategy on public safety and community wellbeing in the downtown area.

Awards



Constable Lumgair - Exemplary Service

In February of 2025, Constable Lumgair became involved in a highly complex and sensitive child exploitation investigation. Recognizing the gravity and urgency of the situation, Constable Lumgair took decisive action, collaborated closely with several agencies and multiple specialized units within the Brandon Police Service, and ensured a thorough and coordinated investigative response. She displayed leadership, attention to detail, and unwavering determination. Thanks to Myriam's actions - and the dedication of all units and members involved - the suspect was taken into custody to await trial. This critical outcome not only ensured justice for the victims but also prevented further harm from occurring.

Constable Menzies was among the first officers on scene to an incident at Neelin High School. Demonstrating quick thinking and physical determination, he used his momentum and adrenaline to force open a locked door, enabling other Brandon Police Service members to gain rapid entry. Once inside, he confirmed that the immediate threat had been neutralized and quickly shifted focus to providing critical first aid to an injured individual.

Constable Menzies' demeanor remained calm, focused, and professional throughout the event. He demonstrated exceptional clinical judgment in assessing the injuries and immediately began administering life-saving interventions. He also gave clear and effective direction to other officers on scene, ensuring that all necessary medical and tactical steps were taken without delay.

Constable Menzies displayed extraordinary courage, leadership, and care under pressure, and his actions brought great credit to himself and the policing profession as a whole.



Constable Menzies - Exemplary Service

On June 10, 2025, at approximately 1:15 PM, Constable Linov received a direct phone call from a distressed student at Neelin High School. The caller reported that a male individual was behaving erratically inside the school and was armed with a sword. Recognizing the urgency and severity of the situation, Constable Linov immediately notified the Communications Centre and proceeded to the location in his cruiser.

Arriving on scene at 1:18 PM, Constable Linov met with Constable Patel. Without hesitation, both officers entered the building to respond to the active threat. Their decisive action and coordinated approach led to the swift identification and location of the armed individual. Utilizing appropriate use-of-force options, Constables Linov and Patel successfully subdued the suspect and by 1:21 PM, the subject was disarmed, restrained, and placed under arrest, effectively neutralizing the threat. While multiple members of the Brandon Police Service promptly responded to the scene to assist with this highly dangerous and chaotic incident, it was the rapid intervention and composed teamwork of Constables Linov and Patel that prevented a potentially catastrophic outcome. Their quick thinking and tactical execution were critical in avoiding what could have escalated into a mass casualty event. The incident, though traumatic for those involved, was handled with exceptional professionalism and efficiency.

The community's confidence in their police service was further strengthened by the officers' actions during this critical event. In the aftermath, Constable Linov continued to demonstrate outstanding commitment by providing support to students and staff affected by the incident. He remained present and accessible, offering comfort and

reassurance to those in distress. In addition, he engaged with school administrators to review safety protocols and assist in planning for improved emergency preparedness moving forward. There is no doubt that Constables Linov and Patel are deserving of formal recognition. Their courage, composure, and professionalism in the face of a life-threatening emergency exemplify the highest standards of the Brandon Police Service.

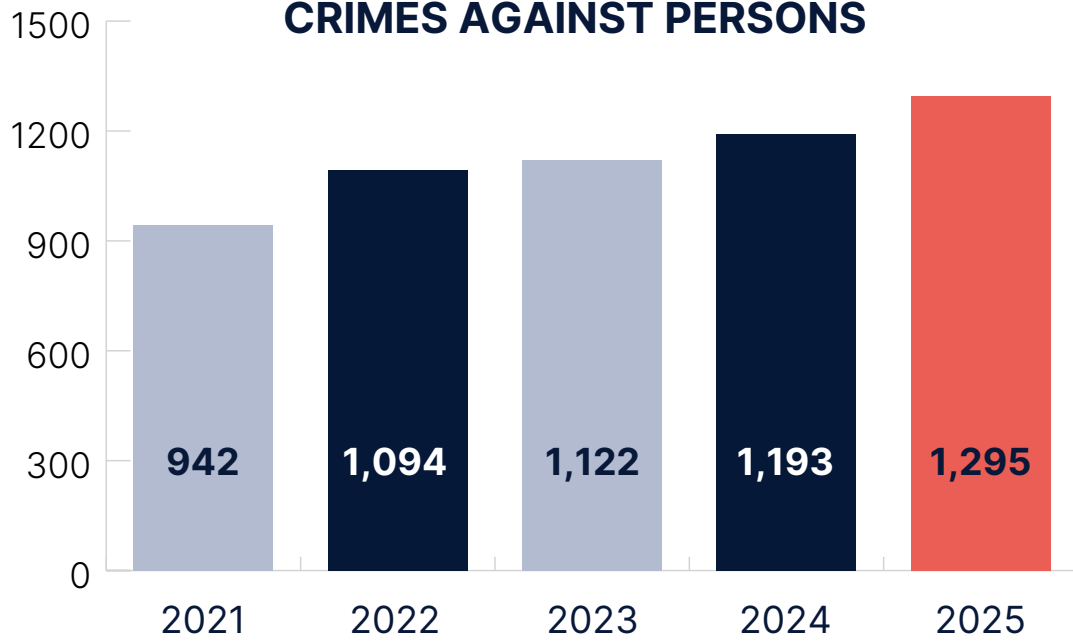

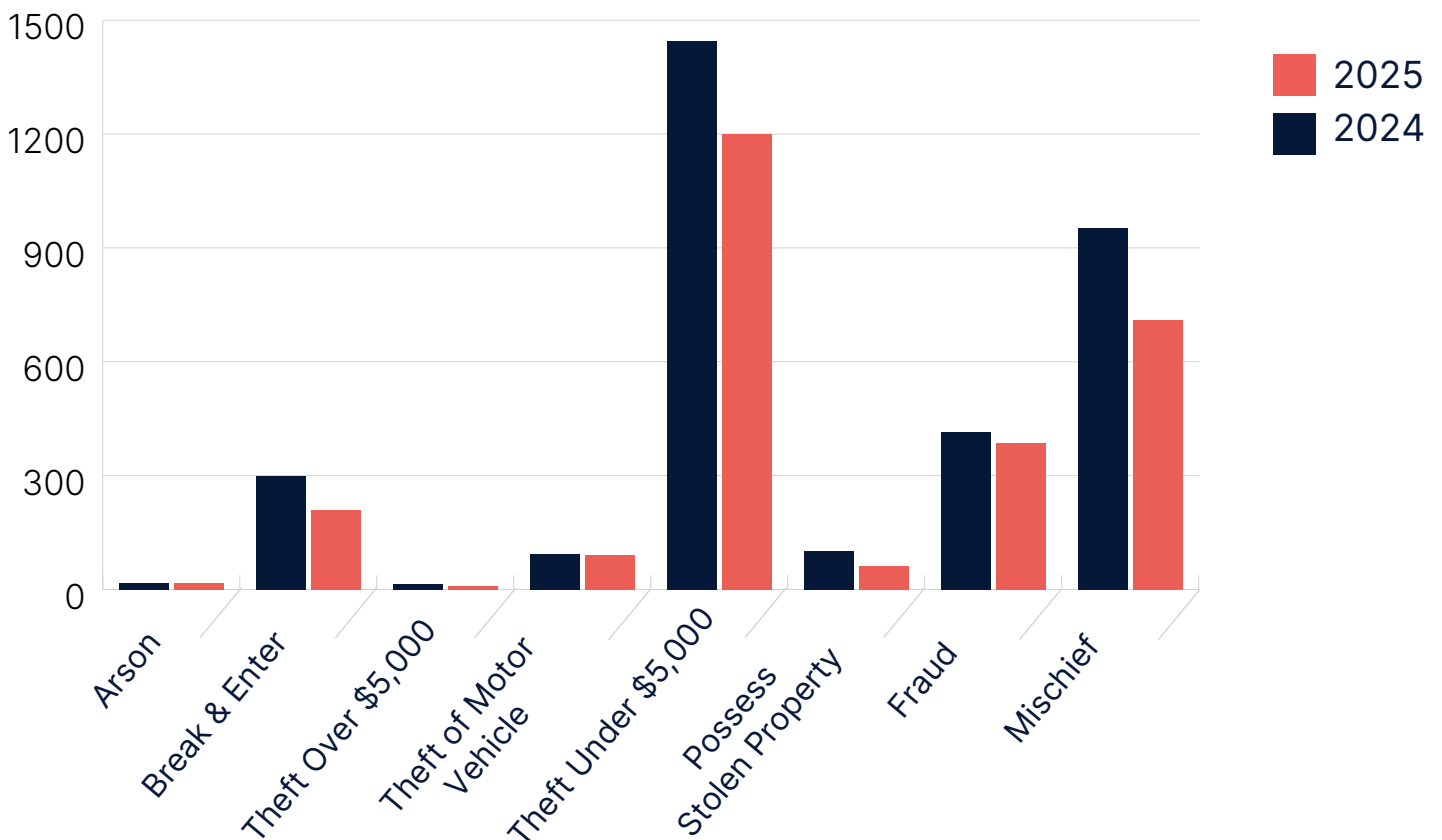

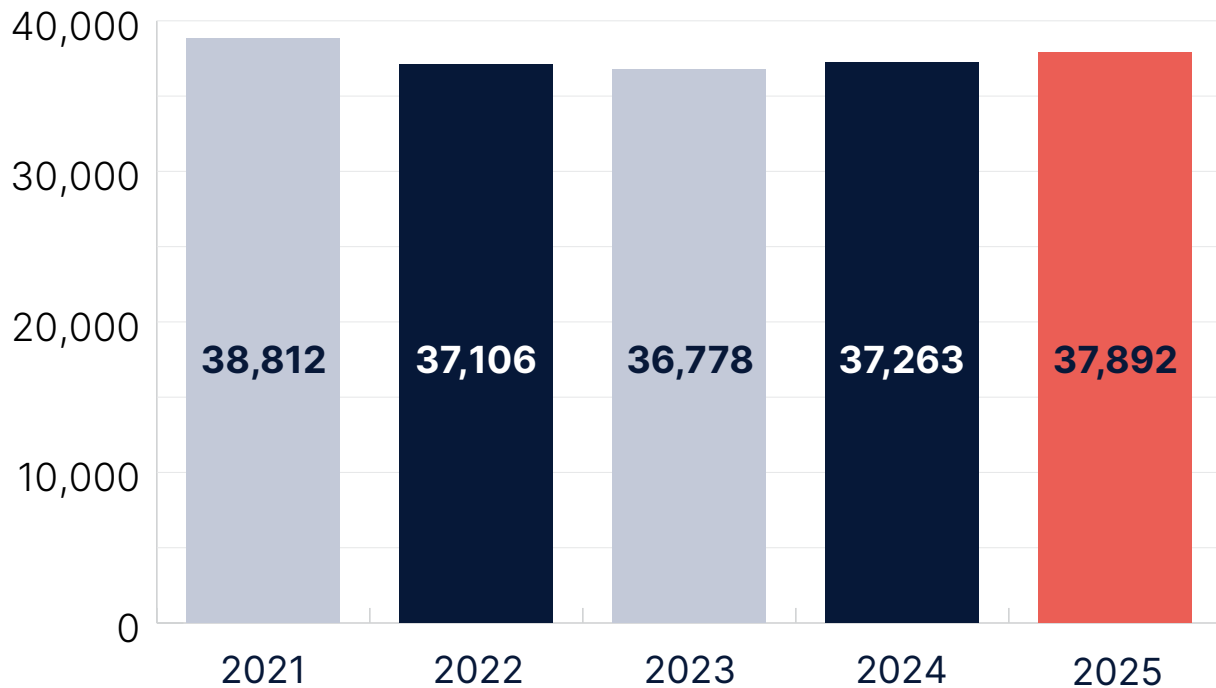

Cases of Interest

In January 2025, the Brandon Police Service Organized Crime Section initiated an investigation into individuals involved in the trafficking of fentanyl within the City of Brandon. On February 14, 2025, at approximately 4:30 a.m., police conducted a traffic stop on a vehicle returning to Brandon from Winnipeg as part of the ongoing Controlled Drugs and Substances Act investigation.

Four occupants were located in the vehicle and taken into custody. A subsequent search of the vehicle resulted in the **seizure of approximately 14.8 grams of methamphetamine and a .38-calibre handgun**. Continued investigation revealed that one of the female occupants was concealing a quantity of illicit substances internally. She was transported to hospital, where approximately **16.4 grams of fentanyl were safely recovered and seized**.

As a result of this investigation, all four adult individuals were arrested and charged with numerous drug and firearm related offences.


The estimated street value of the seized methamphetamine is approximately **\$1,480** at the point level, while the fentanyl is estimated to have a point-level street value of approximately **\$9,840**.

In February 2025, the Brandon Police Service Organized Crime Section initiated an investigation after receiving information that a female suspect was trafficking large quantities of **cocaine and methamphetamine** within the City of Brandon. On *April 5, 2025*, the suspect was stopped near Carberry, Manitoba, while returning to Brandon from Winnipeg.

The suspect was arrested under the Controlled Drugs and Substances Act, and a search of the vehicle resulted in the **seizure of approximately 1.2 kilograms of methamphetamine**. Following the arrest, a search warrant was executed at a residence located in the North End of Brandon. As a result of the search, police seized approximately **500 grams of cocaine and an additional 42 grams of methamphetamine**. As a result of the investigation, the suspect and a female co-accused were arrested and charged with possession for the purpose of trafficking methamphetamine and possession for the purpose of trafficking cocaine.



The combined estimated street value of the seized drugs is approximately **\$110,000**.



In February 2025, members of the Brandon Police Service Major Crime Section, including investigators from the Internet Child Exploitation and Child Abuse units, initiated an investigation following a notification from the National Child Exploitation Coordination Centre of Canada. The information received indicated that a Brandon resident was sharing and potentially producing child sexual abuse material.


Through the course of the investigation, police identified a suspect and confirmed his residence, which was determined to be a home operating as a daycare for children. In collaboration with Child and Family Services, officers attended the residence to ensure the immediate safety and well-being of the

children present. ***The suspect was located within the residence and arrested in relation to child pornography offences.***

A search warrant was subsequently executed, and multiple computer systems were seized for forensic examination.

As a result of continued investigation and forensic analysis, the suspect was charged with several offences, including making/producing child pornography, possession of child pornography, accessing child pornography, distribution of child pornography, assault, sexual interference, and sexual assault.

The adult male suspect remains in custody and has entered a guilty plea in connection with this investigation.



The Brandon Police Service Major Crime Section conducted an investigation into a series of ***seven armed robberies***, six of which occurred within the City of Brandon and one in Souris, Manitoba. The offences took place between November 7 and November 20, 2025. In each incident, the suspect concealed their face, used a weapon while threatening violence, and fled the scene in a vehicle prior to police arrival.

Through extensive investigative efforts, with assistance from Patrol members, the Major Crime Section identified the suspect, the vehicle used in the commission of the offences, and several residences associated with the suspect. On November 20, 2025, following a robbery at a west-end convenience store in Brandon, the suspect was located at one of the identified residences and apprehended without incident.

Police subsequently executed three search warrants at residences linked to the suspect, as well as on the vehicle used during the offences.

As a result, ***investigators recovered stolen property from several of the robberies***, the imitation firearm used in the commission of the offences, and clothing worn by the suspect during specific incidents.

The adult male resident of Brandon was charged with multiple criminal offences, including seven counts of robbery, seven counts of wearing a disguise with intent, robbery using a firearm, pointing a firearm, and unauthorized possession of a firearm.

In June 2025, members of the Brandon Police Service responded to Neelin High School following a report of a male inside the school **armed with a sword and behaving erratically**. Initial responding officers located the suspect in a school hallway while he was still in possession of the weapon.

A conducted energy weapon was deployed, and the **suspect was safely taken into police custody**. The male youth suspect was also found to be in possession of two additional edged weapons.

The subsequent investigation determined that the suspect was a student at the school. It was learned that the suspect attended a washroom and later exited wearing a mask, black hat, and black trench coat. The suspect then approached the first victim and, following a brief interaction, assaulted the victim with a sword, causing serious and significant injuries. The victim was able to escape and flee the area.

The suspect pursued the first victim and subsequently encountered a staff member.

The suspect aggressively chased the staff member, who was able to enter a classroom and secure the door. The suspect used an edged weapon to break the classroom door window, narrowly missing the staff member; however, the suspect was unable to gain entry. The suspect then identified a third victim and aggressively pursued them while holding the sword overhead. This individual was able to escape without physical injury.

Shortly thereafter, **police apprehended the suspect, preventing any further harm to students or staff**.

The male youth was subsequently charged with multiple offences, including attempted murder, assault with a weapon, uttering threats, possession of weapons for the purpose of committing an offence, and wearing a disguise with intent to commit an offence. The suspect remains in custody, and the matter is currently before the courts.

The investigation further revealed that all three victims were targeted based on their race.

2025 Wildfire Season



The City of Brandon served as a major host community throughout the Manitoba wildfire evacuation period, supporting **17 different communities over 128 days**, with evacuee numbers peaking at more than **1,175 individuals** accommodated across 12 hotels, a campground, and private residences. No State of Emergency was declared within Brandon; however, municipal departments played a critical role, including Brandon Fire and Emergency Services (BFES), Brandon Police Service, Access Transit, and community partners.

As part of the municipal response, significant overtime was required to sustain operations and service delivery. Overtime costs related to wildfire response activities totaled **\$101,311.05**, which was billed to the Province for reimbursement. These costs reflected increased staffing levels, extended operational hours, emergency deployments, transit support, and ongoing coordination efforts necessary to support evacuees and partner agencies.

Support included emergency response deployment to northern communities, increased BFES staffing, transit services for

evacuees, public safety support, health and childcare coordination, recreational and community programming, and extensive collaboration with Indigenous leadership, community liaisons, and service organizations. The importance of clearly defined roles, strong inter-agency partnerships, effective communication, and the value of First Nations Safety Officers and community liaisons were key lessons identified throughout the response.

The final evacuees returned home on *September 26*, marking the demobilization of Canadian Red Cross operations after **128 days**. The 2025 wildfire season underscored the critical importance of coordinated emergency management, strong partnerships, and sustained municipal capacity to support large-scale, prolonged emergencies.



Compliment an Officer

"I would like to sincerely commend **Officer Huculak** for her outstanding support during my case. Officer Huculak has been incredibly supportive, caring, and professional throughout the entire process. Her compassionate approach and consistent professionalism made a very difficult situation much more manageable, and I truly appreciate her dedication and empathy."



"Our daughter managed to wander off unnoticed from her Kindergarten recess. It was an extremely distressing and upsetting event for us, not only because she is still so young, only recently having turned five, but she is also autistic, amplifying her vulnerability. She does not have the same sense of awareness and danger as is typically exhibited by children her age.

By some incredible stroke of luck **Officer Moshe Linov** happened upon our daughter about eight minutes after she had left the school premises. From what we can gather, Officer Linov observed her walking alone on Richmond Avenue and sensing something was not right, he intervened. Due to this swift intervention, our daughter was in safe police custody before the school noticed she was missing. While we do not have many details, my wife and I feel the need to share how beyond thankful we are for his awareness, perception, and action that morning. His ability to read the situation and then intercede saved our entire family from unspeakable pain and trauma. We are also very thankful to **Officer Raga** for attending and caring for our daughter that morning.

Without Officer Linov's vigilance and prompt action, the outcome that morning could have been far worse."

“Many thanks to the responding members who showed great professionalism, restraint and courage in the face of imminent danger that saved the lives of not only the victim but to the broader student/teacher population at Neelin High School.

The quick response and actions of members prevented what could have potentially been an unimaginable tragedy from occurring and congratulations on preparing ahead of time for potential active threats within the school system.
