HEARING OF PRESENTATIONS:

2025 TWO SPIRIT AND TRANSGENDER DAY OF VISIBILITY (A)

Alyssa Wowchuk and Han Van De Woestyne provided a presentation on Brandon's 3rd Annual Two Spirit and Transgender Day of Visibility Celebration, taking place on Friday, March 28, from 7:30 PM to 10:00 PM at Knox United Church. Han noted that this is a benefit event supporting the Westman Empowerment Fund and the Brandon University Hero Bursary. Han stated that the Two Spirit and Transgender Day of Visibility, celebrated worldwide on March 31, honors the lives and contributions of transgender, two-spirit, and gender-diverse individuals while also raising awareness of the discrimination and violence the community still faces.

COMMITTEE REPORTS:

(A) KEYSTONE CENTRE BOARD VERBAL MARCH 17, 2025

Councillor Luebke provided a verbal report from the recent meeting of the Keystone Centre Board held on March 11, 2025. He noted the Board reviewed and approved the 2025-2030 Strategic Plan, which will be shared with Members this month and then released publicly. He also noted the Keystone Centre reported a net income of \$115,000 through January 31st, with expenses \$250,000 below budget due to the timing of repairs and lower-than-expected hydro and natural gas costs.

Councillor Luebke concluded by stating the Board approved a tender for the Greenspace Conceptual Plan, endorsed separating the Members and Public Annual General Meetings, and will undergo Governance training in April.

(B) PERSONNEL COMMITTEE WRITTEN MARCH 17, 2025

Submitted for consideration was a written report from Lola Oyeladun, Director of Human Resources, from the Personnel Committee meeting held on March 13, 2025. From the report, Ms. Oyeladun highlighted the recently ratified CUPE contract effective January 1, 2024, set to expire December 31, 2027, a 2.5% general wage increase and applicable market adjustments effective January 1, 2025.

The City Clerk advised that City Council had met in a Committee of the Whole Meeting closed to the public on March 17, 2025 to consider a presentation from Administration with respect to an enforcement matter.

(206) EARLY START ON EXPECTED GOPHER INFESTATION

Councillor Parker noted that there was a serious issue last year with gophers in the greenspaces throughout the City and this year was expected to be worse and enquired what was planned to get a head start on the eradication this year.

His Worship the Mayor agreed to take this matter under advisement.

(207) IMPACT OF UNITED STATES TARIFFS

Councillor Luebke enquired as to the potential impact of the current and proposed U.S. tariffs on the City of Brandon, inclusive of information the city's procurement policy with respect to purchasing items from the United States and how same could be avoided.

At the request of His Worship the Mayor, the Acting City Manager responded that, following the lead of the Federal and Provincial Governments, the City of Brandon had formed an internal task force with the intent to be proactive and determine ways to alleviate the effects of the tariffs on the City of Brandon and the community as a whole.

(208) FEDERAL TRANSIT FUNDING ANNOUNCEMENT

Councillor Luebke referred to a recent announcement with respect to Federal Government transit funding. He noted that the funding included a requirement for high density housing in areas close to major transit routes and enquired if amendments to the Zoning By-law were required to meet these requirements.

At the request of His Worship the Mayor, the Acting City Manager confirmed that the Zoning By-law had already been amended to ensure the requirements were met.

Councillor Luebke announced that the Brandon Wheat Kings continued their race for first place with a game against the Saskatoon Blades on Wednesday, March 19, 2025 and their final home game on Friday, March 21, 2025. He wished the team good luck and invited everyone to come out and cheer them on.

ROYAL MANITOBA WINTER FAIR

Councillor Luebke announced that the Royal Manitoba Winter Fair would take place from March 31 to April 5, 2025 at the Keystone Centre. He encouraged everyone to come out and enjoy this fun-filled family event. He also noted that a free children's ticket was available to download on the Provincial Exhibition website.

2025 U SPORTS MEN'S VOLLEYBALL CHAMPIONSHIP

Councillor Luebke announced that the 2025 U Sports Men's Volleyball Championship would take place from March 21 - 23, 2025 at the Brandon University Healthy Living Centre and noted that tickets for some games were still available.

VALLEYVIEW SCHOOL ON-LINE SAFETY PRESENTATION

Councillor Cameron announced that Valleyview School would be hosting an event on March 19, 2025 from 6:30 - 8:30 p.m. where Val Caldwell would provide a presentation for students and parents regarding on-line safety and awareness. He invited everyone to attend this important seminar.
